IIPA Annual Debate-2022

Rules & Regulations

1. The Debate is open for all the Universities and Degree Colleges of Kashmir Division;
2. The debate will be conducted in English language only;
3. The participants must be bonafide students of the participating institution, enrolled for the undergraduate or post graduate courses of study;
4. Research candidates are not eligible for participation in the debate;
5. Each participating University/Campus/College/Department/Institute is entitled to send only one team of two speakers. One will speak **FOR** and another **AGAINST** the motion;
6. Best five speakers will be awarded with cash prizes worth **Rs. 5,000/-** First, **Rs. 4,000/-** 2nd, **Rs. 3,000/-** 3rd and two Consolation prizes of **Rs. 1000/-** each;
7. All the participants will be awarded a certificate of participation;
8. Each speaker will be allowed to speak for 5+1 minutes only (minimum time limit 5 minutes, maximum time limit 6 minutes). Negative marks will be given to those who exceed or lower the time limit;
9. Jury consisting of three judges will evaluate the performance of the speaker on the following criteria:
 - a. **Matter/Content** - the logical reasoning and content presented by the speaker
 - b. **Manner/Style** - Voice Modulation (including suitable use of accents) presentation, delivery & style of speaking of the speakers.
 - c. **Method/Strategy** - structure and organization of speeches made by the speakers.
10. Verdict of the judges will be final and binding open all. No protest or objection with regards to either the decision or the procedure will be entertained.
11. Admission to the debate will be subject to the presentation of a letter of the credentials from the head of the institution certifying the bonafide status of the participants. Identity Cards with photographs signed by the appropriate authorities by the respective Institutions / Departments / Colleges should also be carried by the participants;
12. Speaking order of the participating teams shall be decided on the basis of draw of lots
13. Participants may be accompanied by at-least one teacher-in-charge from the respective institutions;
14. Paper reading will not be entertained in any case.
15. Registration on first cum first serve basis, subject to the availability of seats
(Maximum seats are 30)
16. Please mail the scanned copy of the filled in registration form duly attested by the competent authority of the Institution on the email id given below with "**IIPA Debate 2022**" in the subject by or before 18th July, 2022 .
