Annexure-A

Rules and Regulations for the Debate Competition Event: National Education Day Debate Competition

Topic:

"The Current Education System is Outdated and Fails to Equip Students for Real-World Challenges"

General Guidelines

Eligibility: The competition is open to all students from University Teaching Departments / Satalite Campuses colleges affiliated with the University of Kashmir and other sister universities of Kashmir Division

Registration: Participants must register by 7th November 2024. No entries will be accepted after the deadline.

Team Composition: Each college/university can nominate two participants, with one speaking for the motion and the other against it.

Time Allocation: Each speaker will have 5 minutes to present their arguments. An additional 2 minutes will be allotted for rebuttals and conclusion. Time limits will be strictly enforced, and exceeding the time limit will result in a deduction of points.

Language: The debate will be conducted in English only.

Judging Criteria

- 1. Content and Argumentation (40%): (Depth of understanding, clarity of arguments, and relevance to the topic.)
- 2. Delivery and Presentation (30%): (Clarity of speech, confidence, and overall impact of the presentation.)
- 3. Rebuttal (20%): (Ability to respond to opposing arguments effectively and respectfully.)

Time Management (10%): (Adherence to allotted time and effective use of time for arguments and rebuttals.)

Prizes and Certificates

First Prize: INR 2,000, Second Prize: INR 1,500, Third Prize: INR 1,000

Certificates: All participants will receive certificates of participation, and winners will receive additional merit certificates.

Dress Code: Participants are advised to dress formally.

Arrival: All participants are required to report at least 30 minutes before the event for registration and orientation.
