Check list for Recommending Authority

1. Income Certificate, (online) issued by a Competent Authority in the State/UT Governments is required in original.
2. Category certificate along with verification report of the said certificate by the issuing authority.
3. Course fee receipt in original paid to the institution along with the bonafide certificate clearly mentioning fee details paid during current financial year.
4. The student obtaining benefits under this scheme shall not be allowed to avail the benefits from any other scheme for this purpose (one scholarship for one course).
5. The continuance of scholarship form (for Renewal applicants) will be subject to securing 50% marks in the previous year's examination duly certified by the concerned HoD.
6. Hosteller certificate along with fee receipts in original should be attached with the form.
7. Students should be regular in attendance having 75% of attendance.(certificate of attendance must be attached with the form issued by the HoD)
8. If a student violates University discipline or any other terms and conditions of the scholarship, scholarship may be suspended or cancelled without any further intimation.
9. If a student is found to have obtained a scholarship by false statement, his/her scholarship will be cancelled forthwith and the amount of the scholarship paid will be recovered from him/her and a legal action under rules will be initiated against him/her.
10. It will be necessary for the eligible applicants to provide Aadhaar, mobile number and Aadhar seeded bank account number while applying for the scholarship.
11. PG Students of batch 2022 and 2023 are eligible for scholarships only and batches 2019 onwards for 5 Year UG Integrated courses are eligible if otherwise falling in the criteria.
12. All necessary guidelines of state/national scholarship portal must be followed by the recommending authority/department in letter and spirit and violation of guidelines will be wholly and solely responsibility of the applicant and recommending authority/department.
